BOATER SAFETY CLASS 2014

LETTER FROM THE PRESIDENT

The Village Trustees and staff continuously strive to control our taxes. As you are aware, we were successful on your recent real estate taxes. Based on efforts by the Village and our assessor, Tyler Technologies, with the Wisconsin Department of Revenue (DOR) we were able to get the DOR to recognize the accurate value of residential properties in the Village. These efforts caused our portion of the school and County taxes to decline. Subsequently, there were a number of sales in the Village which will potentially raise the DOR's valuation of the Village's residential property resulting in higher real estate tax payments for us next year. We will continue our efforts to make sure the DOR has accurate values and we only pay an appropriate amount of the school and County taxes.

VILLAGE WOODLOT

The spring opening of the Village woodlot is dependent upon weather conditions. We anticipate the wood lot will be open on April 5, 2014, subject to snow. Open hours will be on Saturdays from 9:00 AM to 1:00 PM, for disposal of leaves, grass clippings and brush. The leaves and grass clippings are hauled out, so they must be kept separate from the brush. Please unload your leaves and grass clippings on the leaf pile.

dumpster will be available for the month of May for Village residents beginning Saturday, May 3rd at the Village woodlot from 9 AM to 1 PM. An attendant will be available to assist you. Items that can be dumped include, but are not limited to: large items, boards, lumber, pipe, fencing & carpeting. You may also bring your old electronics to be recycled. There is a separate bin for the electronics in the wood lot. Electronics may include items such as computers, cell phones, batteries, etc. Contact the Village Hall for a complete list of acceptable electronics.

If you have need of a police officer, but the matter is not a 9-1-1 emergency, please call the police squad directly. If you leave a message at the Village Hall, it may be much later or the next day before the message is retrieved. Calling the squad directly will result in a more timely resolution to the matter of concern.

DOG LICENSES & FEES

The Village requires that all dogs be licensed as per Wis. State Statue 95.21(2)(a). The deadline for registration of your dog is March 31, 2014. If your dog is found not to be licensed, you could receive a citation.

Dog license fees are in compliance with Wis. State Statute 174.05 that states that fees should differentiate between pets that are neutered or spayed and pets that are not. The fee for dogs that are spayed or neutered is \$15.00, and for dogs that are not neutered or spayed is \$17.00. There is a \$5.00 late fee for dog licenses purchased after March 31, 2014.

E-MAIL ADDRESSES

Recently you received a letter from the Clerk explaining that the Village will begin sending the newsletter and special notices via e-mail. We have received many of your e-mails and appreciate anyone who has responded. If you have not yet responded, we would greatly appreciate hearing from you. Some residents do not have e-mail accounts or access to computers. We will continue to send the newsletter via U.S. Mail to those residents who notify us of that. This March mailing is the final newsletter that will be mailed via U.S. Mail to all our residents.

Please note that while we have no intention of providing your e-mail addresses to the public, the Village is subject to open records requests. It is possible that we could receive requests for our e-mail list. We are then required by law to grant that request.

BURNING PERMIT

The 2014 spring burning season has been set. The dates are as follows:

Please remember that you must pay a \$25.00 fee for each spring or fall burning session. Once the fee is paid, you must call the Village Hall (262-567-5301) or the officer on duty (414-881-9727) each time you plan to burn so that the officer on duty is aware of planned burning. Additionally, the Village must have your completed burning permit form. You will be given a copy for your files for reference. The burning regulations are printed on the permit form.

BOARD OF REVIEW & OPEN BOOK DATES

The dates have been set for the Open Book and Board of Review, as well as the dates when the Assessor, Mark Link of Tyler Technologies, plans to be in the Village to review properties. Mark will be in the Village between March 24 and April 11. Letters of assessment notice will be mailed out on or about April 29th. The Assessor will review approximately 20 percent of the properties in the Village. If you would like to assure that your property is reviewed, you may contact Mark directly and request a review. Mark's contact number is 800-959-6876, ext. 1.

The Assessment roll will be available for review at the Village Hall beginning on April 30th. **Open Book** will be held at the Village Hall on **May 13th from 4 PM to 6 PM**. Open Book is the time when property owners have the opportunity to review the assessment roll and speak with the assessor regarding their properties. Anyone who is unable to attend on May 13th may make an appointment to meet with the assessor between May 1st and May 15th. Property owners whose assessments have been revised during the 15-day Open Book period will be mailed revised notices on May 16, 2014.

The **Board of Review** will be held on **June 23rd, commencing at 6 PM**. Objection forms are available at the Village Hall and must be completed and returned to the Village Clerk at least 48 hours prior to the scheduled Board of Review. Property owners who do not submit the required form may still appear before the Board, but their cases may be scheduled for another date to allow the Assessor time to prepare for the hearing.

It is important for property owners to remember that the Open Book and Board of Review are the only opportunities that property owners have to object to their assessments for that property year. Once the Assessment Roll has been accepted by the Board of Review, property owners will not have another opportunity until the next year.

He will be happy to explain the procedures he follows and methods used in determining the assessed values.

SPRING ELECTION INFORMATION

Residents will be casting their votes for Court of Appeals Judge (District 2), Circuit Court Judges (Branches 5 and 6), County Supervisor (District 2) and School District Offices.

A modified version of the election ballot is on the back of this page. The printing on the sample ballot has been reduced to fit on an 8-1/2 by 11-inch page. The ballot you will vote is on legal size paper. It may be very helpful for you to familiarize yourself with the ballot before you go to the polls.

Asentee ballots were mailed on March 10th to those residents whose applications for an absentee ballot were on file with the Clerk. You may contact the Clerk to request an absentee ballot by mail using the application that can be found on the Government Accountability Board (GAB) website (http://gab.wi.gov) or you may request that the clerk send an application by fax or e-mail to you. The last day you may request an absentee ballot by mail is March 27, 2014. Beginning March 17th, you may fill out the absentee ballot application and vote at Village Hall during normal business hours, Monday through Friday, 8 AM—2 PM. The last day to vote by absentee ballot is Friday, March 28th. The office will be open from **8 AM until 5 PM** on that day. No absentee voting may occur after 5 PM on Friday, March 28, 2014. Absentee ballots that are mailed to the Village Hall must be postmarked by April 1, 2014 and arrive via USPS no later than 4 PM on Friday April 4, 2014.

<u>Please note:</u> While the law allows for the late arrival of ballots if mailed on election day, the procedure to process those late ballots is very extensive and it would be greatly appreciated if your absentee ballot is received before 8 PM on Tuesday, April 1, 2014.

You must be registered in order to vote in the election. You can register to vote until 5 PM on the Friday before the election (March 28, 2014) or on Election Day. You must have resided at your address for 28 consecutive days to be eligible to vote, and you may no longer use a corroborating witness as proof of residence. Proof of residence is required when registering less than 20 days before an election, on Election Day, and for first time Wisconsin voters registering by mail.

PHOTO ID REQUIREMENTS:

As of Tuesday, March 6, 2012, Dane County Judge David Flanagan placed an injunction on the requirement to show a photo ID in order to vote. If that injunction is not lifted by the election on April 1st, voters will not be required to show their identification. Voters will still be required to sign the poll book as they have done in the past several elections. Your Village election inspectors have worked very hard to learn the continually changing laws regarding elections. They appreciate your assistance in complying with the laws that are in effect. You are welcome to contact the Village Clerk to verify whether photo ID will or will not be necessary on April 1st. It is not anticipated that the injunction will be lifted prior to the 2014 Spring Election.
