# POLICE OFFICER CONTACT INFORMATION

Please note the police officer contact information listed on the front page of this newsletter in the Village Phone Number box. If you require immediate assistance, but the matter is not considered a 9-1-1 emergency, please remember to contact the officer on duty directly, or contact the Waukesha County Dispatch Center at 262-367-2600. If you leave a message at the Village Hall, it will not be responded to until later in the officer's shift, or the next day during regular office hours. Remember, it is most helpful to the police officers to report anything that may be suspicious activity at the time you see it rather than waiting until a later time. Thank you for your cooperation in this matter.

### DRIVEWAY PLOWING AND MAINTENANCE

The Village DPW plows private drives at the direction of the Police Chief when a snowfall reaches a 3" accumulation. This is done to maintain emergency access only. A more complete driveway clearing is the responsibility of the property owner. All driveways should be clearly marked indicating where the boundaries of the driveway are. Please note that driveways that are not clearly delineated with reflective markers may not be plowed.

Please keep the areas around your driveway trimmed back to 12' wide x 12' high (if possible) to be free of obstruction. This will ensure that emergency services can get to your door. The Village police and local fire services would appreciate your cooperation in this matter.



# VILLAGE DUMPSTER LOCATION AND HOURS

The next dumpster that will be available for Village residents is scheduled for the month of October beginning Saturday, October 3rd.

This dumpster will be located at the Village wood lot and can be used on Saturdays from 9:00 AM to 1:00 PM. during open wood lot hours. An attendant will be present if you need assistance.

Items that can be dumped include large items, boards, lumber, pipe, fencing & carpet. All items must be placed in the dumpster.

The following types of materials or items are absolutely NOT allowed to be placed in the dumpster: construction materials, tires, batteries, hazardous waste products, electronics, or "white goods" (refrigerators, stoves, etc.)

# TRASH PICK UP/HOLIDAY WEEKS

Trash pick up in the Village is normally done on Thursdays by **Advanced Disposal Services (ADS).** When there is a holiday during the week, prior to or on the regular pick-up day, trash pick up will be one day later (Fridays). If you have questions regarding pick up or if you need to arrange for a special pick up, the phone number for ADS is <u>262-367-6040</u>.

Thanksgiving pick up: Friday, November 27

Christmas and New Year's will not be affected

# FALL BURNING

all burning will be permitted in the Village beginning Saturday, October 3rd and is allowed through Sunday, November 15th, <u>when weather conditions permit</u>. If the weather is dry, it is possible that burning will not be permitted. Chief Wiemer will consult with surrounding areas in order to make a decision regarding the safety of allowing burning. Before you burn for the very first time, you must read and sign a copy of the Village Burning Ordinance. If you did not sign an ordinance last season, or need another copy for reference, please contact the Village Hall. If you have previously signed a copy, it is on file at the Village hall. There is a fee of \$25 for the fall burning season.

Once your fee has been paid and your signed copy of the ordinance is on file, you <u>must</u> notify the Village each time before you burn. Please call before 2 P.M. on Friday, if you plan to burn during the weekend. Contact the officers directly on their cell phones after office hours. The contact numbers for the hall and the officers are listed on the front page of this newsletter.

Burning without notifying the Village could result in a citation being issued to you. Following the above procedures will help ensure a safe burning season for everyone.

# VILLAGE WOOD LOT

The Village wood lot is open on Saturdays from 9:00 a.m. to 1:00 p.m. for disposal of leaves and brush. The leaves are hauled out, so they must be kept separate from the brush.

#### Please unload your leaves on the leaf pile.

Because the brush is ground up in a tub grinder, we cannot accept stumps or anything larger than one foot in diameter.



# **BOAT STORAGE & PIER REMOVAL**

As another summer season draws to a close, it is time to begin preparations for winter by removing piers and boats from the lake. There are some specific rules to remember when storing your boats and piers. You may view the Village web site and click on "Zoning Code" for further information and clarification as to the storage of trailers, recreational equipment, piers, lifts, boats and other vehicles and equipment. The portion of the code listing these restrictions is found in section 17.22 (4) of the zoning code.

In a nutshell, here are the basic rules for storing the above mentioned items on your property.


- 1. All boats and trailers with boats must be stored so they are not plainly visible from your neighbor's property.
- 2. Piers, lifts, rafts, and other similar equipment may be stored at the shore if neatly arranged and done in such a way as to minimize visual obstruction from adjacent properties.

What does "not plainly visible from your neighbors' property mean?

A: They are not parked or stored within a public or private street setback unless they are so thoroughly screened by lawfully located structures along with other approved vegetation cover, approved decorative fencing or a combination thereof, that they are not plainly visible.

B: They are at such a great distance, or are so thoroughly screened by lawfully located structures, topography, vegetation cover or approved decorative fencing or combination thereof, that they are not plainly visible.

If any resident has any questions regarding storage of your property on your lands, please call the Village Hall at 262-567-5301. The Village Hall hours are Monday through Friday, from 8 AM to 2 PM. We will be glad to answer your questions. The police department will monitor this storage this fall for compliance.



# 2015 TAX COLLECTION

All 2015 tax payments will be collected by Waukesha County. <u>Payments will not be</u> accepted or receipted at the Village Hall.

<u>To Pay By Mail</u>: Payment can be made using the return envelope provided with your tax bill. **Make sure the check is made payable to Waukesha County Treasurer**. A receipt will be mailed to you from the County Treasurer.

<u>To Pay In Person</u>: Payment can be made in person at the Waukesha County Treasurer's office, located in the Waukesha County Courthouse at 515 W Moreland Blvd, Room 148, Monday-Friday,

8:00 a.m. to 4:30 p.m.

Escrow Checks: If your escrow check is more than the amount of your taxes, contact the issuer to have a new check issued for the exact amount of your taxes. If your check is not for the exact amount, a refund check from the Village for the overpayment will be sent but may take up to 6 weeks to process. Make sure your escrow check is made payable to the Waukesha County Treasurer.

#### PLEASE KEEP PROPANE TANKS AND PRESSURIZED CONTAINERS OUT OF THE RECYCLING BIN It is essential to properly dispose of old propane tanks so they don't hurt anyone,

including yourself, your family or your local recycling and sanitation workers.

# PLAY IT SAFE

ave an old propane tank? Unsure how to recycle it? Play it safe. If tanks are not completely empty, they present a real danger in the waste stream because they can cause fires, explosions, serious injury or death if put into compactor trucks, recycling centers and other waste management equipment. PLEASE DON'T PUT THEM IN THE TRASH OR THE RECYCLING CART. In addition, you should not open a tank and let the propane leak into the air, as this could cause a dangerous situation

# WHAT SHOULD YOU DO WITH YOUR PROPANE TANK?

First—see if the tank is still usable, and have it refilled as an alternative to disposal. Bring it to your local propane supplier to have it inspected and refilled. If the tank is unsafe to use, or you no longer want it, many retailers have an exchange program, so you can swap out your old, empty tanks for new, full ones, and they will recycle it properly. Some areas accept propane tanks (and other pressurized cylinders) at their hazardous waste drop off sites.
