Ordinance No. 35

To Prohibit Trespass on Lands and to Prescribe Penalties Therefor.

The Village Board of the Village of Oconomowoc Lake do ordain as follows:

- (1) Whoever does any of the following may be fined not less than \$10.00 nor more than \$25.00 for each violation, together with costs of action, and in default of immediate payments thereof, shall be imprisoned in the County Jail of Waukesha County until such forfeiture and subsequent costs have been paid, but not to exceed 30 days!
- (a) Enters upon any land of another within the Village of Oconomowoc Lake for the purpose of datching or killing any birds, animals, or fish on such land, or removing or gathering anything located or growing on such land, without the express or implied consent of the owner or occupany to engage in any of those activities, or after having been notified by the owner or occupant not to engage in any of those activities:
- (b) Enters upon the land of another within the Village of Oconomowoc Lake for the purpose of gaining access to any lake, pond, river or stream located in such Village, without the express or implied consent of the owner or occupant to do so, or after having been notified by the owner or occupant not to do so.
- (2) A person is deemed to have received notice from the owner or occupant with the meaning of this section if he has been notified personally, either orally or in writing, or if the land is posted. For land to be posted, a sign at least eleven (11) inches square must be placed in at least two conspicuous places for every 40 acres to be protected. The sign must carry appropriate notice and the name of the person giving the notice followed by the word "Owner", if the person giving the notice is the holder of legal title to the land, and by the word "Occupant", if the person giving the notice is not the holder of legal title, but is a lawful occupant of the land.

All ordinances or parts of ordinance in conflict herewith are hereby repealed.

This ordinance shall take effect and be in full force after its passage and posting.
