### PRESIDENT ANNOUNCES CLOSED SESSION

President Birbaum announced that the Village Board of Trustees will: "convene into executive closed session by roll call vote, pursuant to Section 19.85(1)(g), Wisconsin State Statutes, 'conferring with legal counsel for the governmental body who is rendering oral or written advice concerning strategy to be adopted by the body with respect to litigation in which it is or is likely to become involved', regarding the excessive assessment claim of Mart A. Olson in regard to his real estate property located in the Village of Oconomowoc Lake with tax key number OCLV 0585-974-001. Participating in the executive closed session will be the Village Board, Village Attorney, Village Administrator, and Village Clerk-Treasurer."

### **ATTORNEY**

Discussion/action regarding an ordinance to repeal and re-create Section 9(e) entitled Closing Hours of Section 12.03 of the Municipal Code of the Village of Oconomowoc Lake Entitled Intoxicating Liquor and Fermented Beverages, two possible drafts, per correspondence from Mr. Macy dated December 27, 2011

Mr. Macy explained the law change that allows for the sale of beer and liquor at 6:00 a.m., with the closing of sales for beer at midnight and liquor at 9:00 p.m. The first draft Mr. Macy provided only changes the time from 8:00 a.m. to 6:00 a.m. for all carryout sales. The second draft would, in addition to allowing beer and liquor sales to start at 6:00 a.m., also allow the sale of beer to continue until midnight, which adopts state law in regards to closing hours. Mr. Wiemer advised that Roundy's, d/b/a Pick N Save, has made the request to sell beer and liquor beginning at 6:00 a.m., and ending at 9:00 p.m.

Motion (Shult/Bickler) to adopt Draft 1 which repeals and re-creates Section 9(e) entitled closing hours of Section 12.03 of the municipal code of the Village of Oconomowoc Lake entitled intoxicating liquor and fermented beverages, *Carried Unanimously*.

In order to do so, the Board of Trustees must approve the legal description. The change in the legal description of the Village of Oconomowoc corporate limits as of December 1, 2011 is the addition of the entire roadway known as E. Wisconsin Avenue along the north side of the business district.
