#### **MINUTES**

Motion (Kneiser/Steinbach) to approve the November 17, 2003 Village Board regular meeting minutes and public hearing minutes, and to approve the December 1, 2003 public hearing minutes and special Village Board meeting minutes, with the following revision, *Carried Unanimously*.

Motion (Kneiser/Steinbach) to approve the appointment of Kathy Kreuser as Village Clerk and to approve a resolution authorizing her to sign Village checks, <u>Carried Unanimously.</u>

#### Sewers

The Trustees discussed a letter dated Dec. 1, 2003, from Diane Gard, City Administrator, City of Oconomowoc, requesting information regarding the possibility of sewers for 16 residences on South Beach Road. Trustee Fischer directed the clerk to send Ms. Gard a letter stating that he and Trustee Schinzer will be meeting with the property owners and will be responding with the requested information.

### **PLAN COMMISSION**

R-4 Zoning Map and R-2 Zoning Map for Annexed Properties on Sawyer Road Attorney Macy explained the need for zoning amendment procedures for land in the Lalumiere subdivision.

Motion (Steinbach/Kneiser) to initiate zoning amendment procedures for land in the Lalumiere Subdivision annexed to the Village of Oconomowoc Lake in December 2000, to rezone the land to the R-4 district, by referring the matter to the Village of Oconomowoc Lake Plan Commission for recommendation, <u>Carried Unanimously</u>.

The Trustees directed the clerk to also refer zoning amendment procedures for land on Sawyer Road annexed to the Village in December 2000, to the Plan Commission.

### **ATTORNEY**

### Waukesha County Street Width Map

Attorney Macy reported he sent a letter to Waukesha County Parks and Land Use Manager and has not yet received a response.

# Gifford Road Railroad Crossing

Mr. Macy stated Attorney Riffle filed a Stipulation and Order with the Office of the Commissioner of Railroads regarding the Gifford Road railroad crossing.

### **Extraterritorial Plat Approval Jurisdiction**

Mr. Macy reported a waiver was signed by the Town of Summit. He will draft a subdivision control ordinance and this item will be placed on the January Plan Commission agenda for recommendation to the Village Board and setting the date of public hearing.

#### Aunt Polly's Washtub

Mr. Macy reported a representative of the Pabst's Farm Development made a presentation to the Town of Summit Plan Commission, regarding creating a park at Aunt Polly's Washtub. Mr. Foster will further research this item.

### **Lalumiere Wetland Mapping**

# 2004 Ambulance Service Contract with City of Oconomowoc

### **Police Equipment**

Mr. Wiemer advised the Board that police equipment will need upgrading in the future. An estimated \$30,000 will be necessary to buy computer and radio equipment for the police squads. Mr. Wiemer will be researching grant opportunities regarding this expense.

#### Update on Milfoil

Mr. Foster stated that more information is needed before the Board makes a decision regarding spraying milfoil in the lake. Representatives from the DNR will be invited to a future meeting to discuss the pros and cons of spraying.

### **BOARD OF ZONING APPEALS**

The Board of Zoning Appeals met on December 8, 2003, and released a deed restriction on property owned by Gordon Steinbach, 4775 Hewitt's Point Road.
