Ms. Beyler, DNR, gave a presentation to the Board on the 2004 comprehensive Fish survey and musky evaluation on Oconomowoc Lake. Ms. Beyler stated the bluegill population has reappeared in Oconomowoc Lake since the last survey in 1994. Discussion followed.

The Board asked if there were any options on reducing the bag limit on bluegills during spawning season. Discussion followed.

The Village Board directed the Village Administrator to draft a resolution supporting a reduced bag limit on bluegills.
