Motion (Kneiser/Fischer) to approve the June 19, 2006, Village Board meeting minutes, <u>Carried Unanimously.</u>

Action regarding a donation through the Waukesha Foundation to the Police Department for the purchase of patrol boat and equipment.

Mr. Wiemer explained the Waukesha County Community Foundation has forwarded a donation of \$16,155.00 to the Village Police Department for the purchase of a patrol boat and equipment. Mr. Wiemer stated the donation was from an anonymous donor. Discussion followed.

Motion (Kneiser/Birbaum) to accept the \$16,155.00 donation from the Waukesha County Community Foundation and follow the restrictions of the donor by placing it in a designated fund balance, *Carried Unanimously*.

# <u>Developing a Compliance Assurance Plan for Recycling Program under Section NR544-04(9), Wisconsin Administrative Code.</u>

Mr. Macy stated that all municipalities have to develop a Compliance Assurance Plan by August 1, 2006. Waukesha County is taking the position that they will write the Compliance Assurance Plan for all the municipalities. Mr. Macy stated he wanted to verify that the Village would be in compliance.

# <u>Discussion/action regarding an Ordinance to Repeal and Recreate Sections 17.39(2), 17.40(2) and Repeal and Recreate Section 17.60 of the Zoning Code concerning Architectural Review Standards. Draft dated June 20, 2006.</u>

Mr. Macy explained the Ordinance reviewing Architectural Review standards was the final draft for the Board's consideration.

Motion (Fischer/Kneiser) to approve the Ordinance to Repeal and Recreate Sections 17.39(2),17.40(2) and Repeal and Recreate Section 17.60 of the Zoning Code concerning Architectural Review Standards as presented through a super majority vote, <u>Carried Unanimously.</u>

# <u>Update on Okauchee Fire Department's request to provide ambulance service to the Village of Oconomowoc Lake.</u>

# <u>Update on Ms. Moore recommendations regarding a Public Opinion Survey</u> for Smart Growth.

Mr. Wiemer explained that Ms. Moore, our consultant for Smart Growth, recommended that the Village develop their own survey on the Village's website rather than participate in the Waukesha County public participation survey. Discussion followed.

#### Discussion/action regarding incorporation of the Town of Richfield.

Mr. Wiemer explained the Town of Richfield was requesting incorporation as a Village. Discussion followed.

Motion (Kneiser/Birbaum) to authorize the Village Administrator to notify the Town of Richfield that the Village has no objection to their request of incorporating into a Village, <u>Carried Unanimously.</u>

## Discussion/action regarding Hewitt's Point Road paving bids.

Mr. Wiemer explained the Village received three (3) bids for paving Hewitt's Point Road. Mr. Wiemer explained if the overlay was reduced from 1-1/2" to 1-1/4" the Village could asphalt the approach on private driveways that had water pockets for the same price. Mr. Wiemer stated after consulting with Payne & Dolan and Rob Davy, Village Engineer, that the 1-1/4" would be sufficient for paving Hewitt's Point Road.

Motion (Schinzer/Fischer) to approve the paving bid for Hewitt's Point Road from Payne & Dolan for \$36,826.00 with 1-1/4" overlay as discussed, *Carried Unanimously*.

Mr. Wiemer gave an update on Officer Steve Wagner's disability leave.
