•	Subject to the current license issued to the premises located at
	36863 E. Wisconsin Avenue being released to the Village Clerk or
	in the alternative expiration of the same.

- Subject to a seller's permit number being filed with the Village Clerk.
- Subject to payment of all outstanding fees, costs and assessments due and owing to the Village.
- Additional Condition: Subject to obtaining a conditional use permit for the premises.
