# OCONOMOWOC LAKE VILLAGE BOARD MEETING MINUTES OF MONDAY, July 20, 2020, Unofficial until approved by the Village Board. Approved as written (X) or with corrections ( ) on 0 8/17/2020.

#### MINUTES

#### Motion to approve June 15, 2020 Special meeting minutes.

#### PUBLIC COMMENT

Ed Johnson wanted to thank the Board for the great fireworks display on July 4<sup>th</sup>. He advised he had heard no complaints, and the new placement of the barge worked wonderfully.

#### **POLICE CHIEF**

Chief Helwig turned this agenda item over to Lieutenant Janicsek. Lieutenant Janicsek gave the Board citation statistics comparing this time last year to this year. Even with limitations on contacts due to COVID-19 through March, April and May, the citation numbers were comparable. Lieutenant Janicsek also advised that due to speed complaints on North Beach Road and West Beach Road, there has been extra speed enforcement during weekends when those roads are the busiest. He advised that mobile speed sign has been moving around the Village weekly with an emphasis on West Beach Road, North Beach Road, and Armour Road.

#### **VILLAGE TRUSTEES**

Trustee Fischer expressed his concern about all of the wake boats driving the shorelines and making the lake unusable for other lake activities. Trustee Zimmermann advised that this is an issue for multiple Waukesha County municipalities and Lake Districts, but there is not much more the Village can do besides educating the residents and public. Lieutenant Janicsek did advise that the boat patrol has been out at different times, and also the DNR has been patrolling as well. The Board requested that staff prepare an email blast or social media post advising of boating regulations.

Trustee Fischer advised he had noticed that the water quality is extremely low, possibly flowing from the LaLumiere and Pabst channels. President Bickler requested that possible creation of a taskforce for Oconomowoc Lake water quality be placed on the agenda for next month.
