Discussion/action regarding Lake Country Fire & Rescue

Fire Chief Fennig presented the Board of Trustees with the opportunity to become partner of Lake Country Fire and Rescue, which the Village currently has a contract with. This partnership currently includes City of Delafield, Village of Chenequa, and Village of Nashotah, with three other communities possibly joining. This partnership would give the Village of Oconomowoc Lake two members on the Fire Commission and two members on the Fire Board for Lake Country Fire and Rescue. The proposed funding formula would be 65% through fixed calculator, and 35% through funding formula (Call volume, equalized value improvements only, and population), and the Village would be responsible for 4% of the capital equipment fund for Lake Country Fire and Rescue. There would be no extra costs in 2020 to become a partner of Lake Country Fire and Rescue. The total cost to the Village of Oconomowoc Lake in 2021 would be approximately \$98,592 for fire protection and emergency medical service coverage.

After the appropriate announcement by the Meeting Chairman, the Board will enter, by roll call vote, into Closed Session pursuant to Wis. Stats. 19.85(1)(e) "Deliberating or negotiating the purchasing of public properties, the investing of public funds, or conducting other specified public business, whenever competitive or bargaining reasons require a closed session." (Fire Service)
